

PRIVACY POLICY

A. GENERAL

- 1.1 Awaaz.De is committed to the protection of personal information provided by the users to us. You agree that your use of Awaaz.De's Services or Website or Awaaz.De's interface (the "Website") implies your consent to the collection and use of your personal information (or your children's personal information) in accordance with the terms of this Privacy Policy.
- 1.2 We at Awaaz.De take the privacy of its users seriously. We are committed to safeguarding the privacy of our users while providing a personalised and valuable service.
- 1.3 No user information is rented or sold to any third party. When a user uses the Website, Awaaz.De may collect users' mobile phone number and other personal information. A high standard of security is maintained by Awaaz.De for its users; however the transmission of information via the internet or telephone is not completely secure. So, whilst we will do our best to protect user information, particularly with respect to protection of personal data, we cannot ensure the security of user data transmitted to us via the internet, telephone or any other medium

B. INFORMATION COLLECTED

- 2.1 We collect personal information from you at registration and other times (for instance, when you use the Website) such as [your name, email address, postal address and mobile phone number].

- 3.1 We do not disclose your information to any third parties other than Awaaz.De's affiliates.
- 3.2 We also use information in aggregate form (so that no individual user is identified):
 - (i) to build up marketing profiles;
 - (ii) to aid strategic development ;
 - (iii) to manage our relationship with advertisers and partners; and
 - (iv) to audit usage of the Website.
- 3.3 Awaaz.De reserves the right to disclose personal information if required to do so by law or if we believe that it is necessary to do so to protect and defend the rights, property or personal safety of Awaaz.De, the Website, or its users.

D. YOUR ACCEPTANCE OF THIS POLICY

- 4.1 By using this Website, you consent to the collection and use of your information by Awaaz.De and to this Privacy Policy. If we change the Privacy Policy then we will post these changes on this page.
